## 3-on 3 Game Rules

Games begin right after NMU Club team plays the Marquette Mutineers at noon Saturday, February 10, 2018.

Rink is next to Lions Field near Vandeenboom School in Township (2213 Summit St).

**The goal is to have good, old-fashioned fun.**

- Players agree to follow the ref’s whistle and agree that ref’s decisions are final.
- Play runs concurrently on each half of the ice surface (approx. 70' by 75').
- Four players per team (no roster changes after registration).
- Games are two ten-minute periods with a one-minute rest between periods.
- No slap shots at any level.
- No checking! Checking is a minor penalty.
- Minor penalties will result in a penalty shot for the opposing team.
- If a player checks repeatedly, a major penalty will be assessed.
- Major penalties will result in a three-minute penalty and a game misconduct.
- Fighting will result in disqualification for the player. No substitution allowed.
- Team members can have matching jerseys.
- USA Hockey rules apply in all other circumstances, except icing.
- Game tiebreakers will be a shoot-out.
- No off-sides. All face-offs at center ice.
- Mercy rule applies: eight-goal difference will result in running time.
- Goals are placed against the side boards & No Goalies
- 16-bracket single-elimination Tournament Format
- We will attempt to match ages in the first bracket.
- A helmet is required, pads are not.
- Skaters provide their own gear.
- Participants must fill out Team Consent forms with signature
- Goals will be moved some to accommodate rough ice.
- Township staff will monitor ice and clean and repair as appropriate.
- Refs are to be respected and followed as appropriate.
